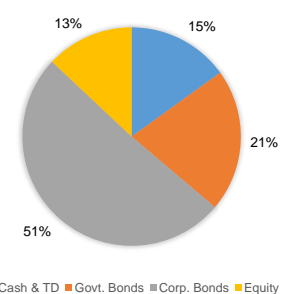

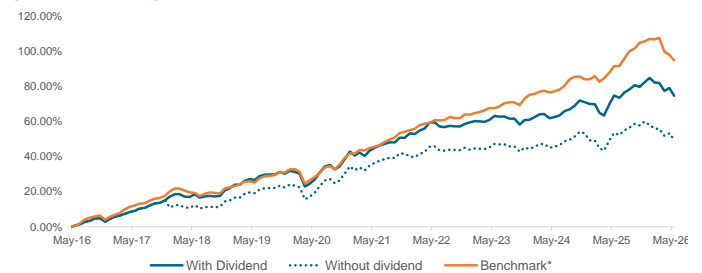
% Portfolio Composition
