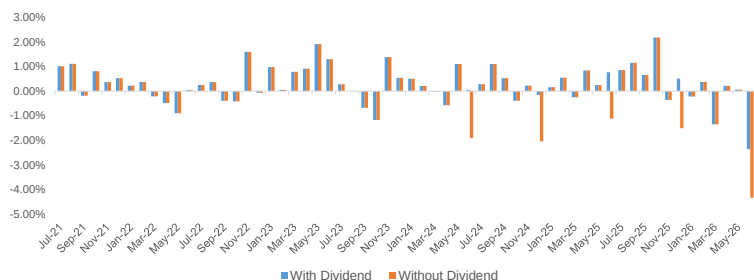


Risk Level: Medium

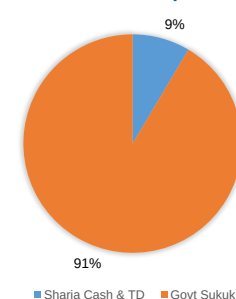

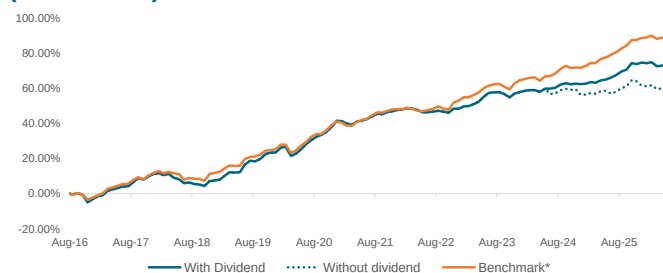
% Portfolio Composition
